

Global V C S Privacy Policy

Information We Collect & How We Use It

When you fill in the online contact forms on our website we need to know your name and other information such as your e-mail address, telephone number, company affiliation, etc. By submitting this information you consent to use of the information in accordance with this Privacy Policy as amended from time to time.

We collect personal information from you on this website only when you fill in the contact form. It is used only to enable us to contact you by email regarding your request. In that email you will be asked whether you agree to your details being passed to one of Global V C S' fulfilment partners, and only if you agree will your information be passed to them.

We also work with third party service partners, who provide us with data collection, storage and reporting services. Under no circumstances are these partners permitted to use your information in any manner, other than to help us make our site more useful and efficient for our visitors.

The appropriate Global V C S fulfilment partner may not be in the UK, and so, by agreeing for us to provide them with your details, you are also agreeing to your data to be transmitted to the country of that partner. Global V C S partners in the European Economic Area (EEA) are required to have a similar standard of protection of personal data, but this is not always the case in countries outside the EEA. We do sometimes transfer data outside the EEA, but before doing so take steps to ensure that your data will be given adequate protection as required by the UK Data Protection Act.

You will also be asked whether you wish Global V C S to send you information about Global V C S products and offers, and we will send you such information only if you agree.

You may at any time inform Global V C S by email to contact@global-vcs.com that you no longer wish to receive information from us and/or that you no longer want us to provide your details to a fulfilment partner.

We may also use aggregate information and statistics for the purposes of monitoring website usage in order to help us develop the website and our service and may provide such aggregate information to third parties. These statistics will not include information that can be used to identify any individual.

Accuracy of and Changes to Your Information

You may request Global V C S to send you information about the personal information we hold on you. To do so, please send a request, specifying as well as you can, the information you require, and we will try to provide it to you without your having to make a formal request.
